PREVAIL BANK DONATES \$2,500 TO "OPERATION WARM"

(Stevens Point) Twenty-five hundred dollars (\$2,500) was donated to the Stevens Point Fire Fighters Local 484 Charitable Foundation by Prevail Bank for the purpose of buying winter jackets for elementary students in need from 16 different schools in Portage County.

"We are proud to support Stevens Point Fire Fighters' Operation Warm initiative," said Dustin Dietel, Prevail Bank Branch Manager of Stevens Point. "We're a community bank that is passionate about economic development, financial stability, and the welfare and growth of individuals, families, and businesses."

"There are many elementary aged students who do not own a winter jacket within the Stevens Point Public School District and parochial schools," said Jason Pettis, Chairman of the Stevens Point Fire Fighters Local 484 Charitable Foundation, Inc. "Operation Warm's goal is to provide every student in need a new winter jacket. Prevail Bank's donation helps ensure that goal is met."

Stevens Point Fire Fighters Local 484 partnered-up with the International Association of Fire Fighters (IAFF) and Operation Warm in 2015. It has provided new jackets to elementary-aged children every year since. Last year, 300 jackets were purchased, personally fitted to every student, and handed to them with their name written inside.
